### NYSTRS to Host ECR Webinar

The continued downward spiral of the financial markets has left many NYSTRS participating employers wondering what effect these developments will have on Retirement System funding. Specifically, school officials are seeking long-term Employer Contribution Rate (ECR) projections so they can budget accordingly.

Administrative Bulletin 2008-11, issued earlier this month, reiterated the ECR applicable to 2008-09 salaries will be 7.63% and stated the rate applicable to 2009-10 salaries will be between 6.0% and 7.0%. However, it also noted unless the markets experience a sharp upswing in the next year, the ECR applicable to 2010-11 salaries will increase significantly.

In an effort to help employers with budget planning, NYSTRS' Actuary Richard A. Young will be the host of a webinar **Thursday, December 11, 2008 from 10 a.m. to 11 a.m.** Mr. Young will discuss how the Retirement System is funded, how the ECR is determined and what the recent market downturn means for future ECRs. He will also answer questions from webinar participants.

The webinar requires participants to have access to a telephone and a computer with Internet capability. While all NYSTRS participating employers are invited to take part, **districts are asked to please use only one telephone line per district** as the number of incoming lines is limited. Utilizing district audio/visual capabilities may allow for multiple participants per district and will ensure more employers can participate in this important informational session.
